Public Inquiries and Inquests

Hannah is an experienced Inquiry counsel and is ranked by Chambers & Partners in this area. Hannah currently represents the Welsh Government in the UK Covid-19 Inquiry into the national response to and the impact of the pandemic, acting as lead junior in relation to Module 6 of the Inquiry, which concerns the impact of the pandemic on the adult social care sector in the UK. She has considerable experience of working closely with technical experts, managing teams of junior counsel – including leading on large-scale disclosure exercises – as well as conducting Inquiry advocacy.

Hannah has been retained as a lead junior counsel to the Grenfell Tower Inquiry since it was established in the summer of 2017, led by Richard Millett KC and Andrew Kinnier KC. Hannah headed a team of juniors working on the modules of the Inquiry concerning the London Fire Brigade's operational response to the fire, fire safety regulation and health and safety in the fire and rescue sector. She examined witnesses in both Phase 1 and Phase 2 of the Grenfell Tower Inquiry hearings.

Hannah has acted for a core participant in the Independent Child Sexual Abuse Inquiry.

Hannah is regularly instructed to represent clients at inquests. She has particular experience of acting for the manufacturers of medical devices and products; care homes; and employers, in relation to workplace deaths.

Product Liability

Hannah advises and represents clients in relation to a range product liability matters, and has particular experience of managing complex, multi-party litigation. She acted for Corin Limited, one of the two lead defendant manufacturers in the metal-on-metal hip group litigation, and is currently instructed by one of the manufacturers in the POP/ SUI vaginal mesh products litigation.

Group Actions

Hannah has considerable experience of group litigation, particularly in the context of product liability and personal injury claims. She was junior counsel for the Ministry of Defence in the Nuclear Test Veterans group litigation, in which the Supreme Court gave judgment for the MOD in what is now a leading case on the meaning of “knowledge” under section 14 of the Limitation Act 1980; has acted for defendant manufacturers in the metal-on-metal hip group litigation and the vaginal mesh litigation; and acted for the Ministry of Defence

in relation to a group of claims brought by current and former members of the armed services for noise induced hearing loss (NIHL).

Hannah's Group Actions practice is complemented by her Inquiry practice, through both of which she has amassed considerable experience of working closely with experts (particularly medical experts) and leading on large-scale disclosure exercises.

Representative Cases

- *The Corin Metal-on-Metal Hip Litigation*

Representing the manufacturer of hip implants defending hundreds of claims by consumers in the High Court.

- *Durrheim & Ors v MOD*

Appeared for the Ministry of Defence in the High Court interlocutory appeal, on the MOD's application for a Group Litigation Order in claims brought by a number of current and former servicemen for alleged noise induced hearing loss (NIHL). The appeals raised issues of combat immunity and scope of duty (see judgment).

- *Ministry of Defence v AB*

Part of the counsel team for the MOD, led by Charles Gibson QC, in the Supreme Court appeal in the group action brought by former servicemen who had participated in the testing of thermonuclear devices in the Pacific Ocean in the 1950's, in which limitation was tried as a preliminary issue (see *alter*). The claimants alleged a wide range of personal injuries and the appeals raised issues of statutory knowledge and novel arguments of causation.

- *Abdale & Others v Secretary of State for Defence*

Acted for the MOD, led by Adam Heppinstall, in the 13 conjoined war pensions' appeals in the War Pensions and Armed Forces First Tier Compensation Tribunal, also arising out of the nuclear testing. Hannah also acted for the Ministry of Defence in the veterans' conjoined appeal against that decision in the Upper Tribunal, led by Leigh-Ann Mulcahy QC and Adam Heppinstall (see judgment).

- *Payday Lenders*

Advised, with William Hibbert, a group of consumers in relation to a prospective group action against a number of prominent payday lenders for alleged breaches of the Consumer Credit Act 1974, the Unfair Terms in Consumer Contracts Regulations 1999, the Consumer Protection from Unfair Trading Practices Regulations 2008, and the Protection from Harassment Act 1997.

Employment

Hannah has substantial experience of employment law, and is ranked in the Legal 500 in the area. She represents claimants and respondents in all types of cases including unfair dismissal, TUPE, wages claims, and whistleblowing, with a particular focus on discrimination claims. She appears regularly in the Employment Tribunal in complex, multi-day trials, and in the civil courts. She acted for a high-profile members organisation, led by Patrick Green QC, in long-running and multi-party proceedings involving allegations of race discrimination, harassment and victimisation. She is a contributor to Tolley's Employment Law Service, and

author of the Equality Act chapter of Tolley's Health and Safety at Work Service.

Hannah is also experienced in litigation involving competition and restrictive covenants, both in relation to employees and former employees, and between business partners and arising out of the sale of businesses.

Hannah is a qualified FRU representative and is on the panel of reviewers for Advocate (formerly the Bar Pro Bono Unit) for employment cases. She is a member of the Employment Lawyers Association.
